Re: Freedom of Information request

Thank you for your request for information under the Freedom of Information Act, which we received on 3 March 2017.

You requested the following information:

- 1) Please provide me with a breakdown of the department's spending via government procurement cards, in annual breakdown over the years 2015/2016/2017, listing how much was spent in each year.
- 2) Please include in this breakdown the amount charged on each occasion over 2015/2016/2017, when it was charged, and what it was for. Please include detail like if any department trips, what the name of the hotel was, or any food what the brand/restaurant was, as is feasible within cost/time limits.

We hold the information you requested. The total spend on procurement cards was £7,626 in 2015, £23,380 in 2016 and, so far, £887 in 2017 (up to the end of February). As detailed below, the OBR's procurement card is most commonly used to pay for staff training courses, office items, stationery and newspaper and other subscriptions.

The OBR relocated from its 20 Victoria Street office to the 102 Petty France building in September 2016. The office move was associated with temporarily higher spending on office essentials and other items to ensure that we were able to operate effectively in our new accommodation. On an ongoing basis, the office move reduces our per-person accommodation and IT services costs.

The OBR seeks to maximize value for money across spending on staffing, accommodation and other costs. For example, as a small organization, we make use of centrally negotiated government contracts wherever possible.

We routinely publish all expenditure over £500 to a single supplier, and the travel and expenses of the Budget Responsibility Committee, on our website at http://budgetresponsibility.org.uk/topics/governance-and-reporting/. All expenditure is recorded in our *Annual report and accounts*, which are audited by the National Audit Office.
